**Sub: Disclosure under Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 - Temporary disruption of operations at Ranjitnagar Plant, District Panchmahal, State Gujarat**

Dear Sir/Madam,

We would like to inform that on 10<sup>th</sup> September, 2025, an incident occurred at the Company's Ranjitnagar Plant, where a minor rupture at one of the bellows in the gas pipeline led to a temporary gas leak. The situation was instantly brought under control through the plant's safety mechanisms. Sprinklers were activated, and the DSC control system safely halted plant operations and all personnel were immediately evacuated from the affected area.

Workers with potential gas exposures were administered immediate first-aid at our on-site Occupational Health Centre (OHC) and few of them were shifted to nearby hospitals for further treatment. We regret to report that one casualty and a few injuries have been recorded. While the post-mortem report is awaited, prima facie it appears to be during the rush of evacuation process. We deeply regret this incident and the loss of life. Our thoughts and condolences are with the bereaved family, and we are extending our full support during this difficult time.

The Company is conducting a detailed investigation and continues to prioritize the highest standards of safety across all its operations.

In terms of the Master Circular no. 		loss for disruption of production is covered under the IAR Policy of the Company.
