The Nomination and Remuneration Committee of the Company had recommended the appointment of Mr. Jay Mohanlal Shah (DIN 0009761969) as an Additional Director and Whole-time Director of the Company for a term of 1 year i.e. from 01st November, 2022 to 31st October, 2023, who is not liable to retire by rotation, to the Board of the Company.
